A CFMS FIELD TRIPS—NORTH FIELD TRIP TO TOPAZ MT. & DUGWAY GEODE BEDS

For the detailed write up for these field trips contact Jim Barton, CFMS-NORTH (contact info below), or go to the CFMS website www.cfmsinc.org for the full version.

- This trip is open to all rockhounds who agree to abide by the AFMS Code of Ethics, the directions of the field trip leader and practice safe rock hounding.
- Call the field trip leader beforehand to sign up and for further information.
- Remember to wear your name badge and sign in with the field trip leader.
- A Consent and Assumption of Risk Waiver of Liability form must be signed upon arrival at meeting site.

TRIP LOCATION: Topaz Mt. and Dugway Geode Beds, Northwest of Delta Utah.

Vehicle access & parking: # 3 at Topaz Mt. & Dugway geode beds. - Good for most vehicles and RV's, no specific handicap parking at Topaz Mt. and Dugway geode beds.

Collection or View Site: From a # 3 at the base of the Mt. to a # 7 at the Red Beryl site, ½ mile or more to site, difficult trails and ravines or water crossings. A # 4 at Dugway geode beds, flat ground, unpaved sections, handicap access with some help.

WHEN: April 5 through April 8 (Thu-Sun). This is a repeating site tour; you may show up and leave at any time during these 4 days. See schedule for optimum arrival dates.

MEMBER'S GUESTS: This is a public collecting area and anybody may camp and collect at the area concurrent with our activities. Those who choose to make the escorted trip to the Red Beryl

COLLECTION MATERIAL: Topaz Crystals, Bixbite (Red Beryl), Pseudobrookite crystals, Hematite crystals, and Geodes.

JUNIORS ACTIVITIES Five New AFMS/FRA Badges to Start the New Year

As I write this month's CFMS Juniors column, I'm frantically attempting to finish five new badge units for our AFMS Future Rockhounds of America Badge Program. These will include badges on the following topics:

- **The World in Miniature:** miniature, thumbnail, and micromount minerals and fossils, as well as sand collecting (suggested by Anne Lowe-Salmon, a juniors leader in Connecticut).
- **Special Effects:** neat mineral effects such as magnetism, double refraction, chatoyancy (cat's eye and asterism), TV stone, and more, along with an opportunity for kids to conduct an "Amazing Mineral Magic Show."
- **Fluorescent Minerals:** why some minerals fluoresce, where to collect them, and how to build a fluorescent display case, while learning about safety in working with fluorescent lighting, particularly shortwave UV.
- **Reaching across Generations:** pairing a senior member to serve as a mentor to a junior mentor to teach some aspect of our hobby that's of mutual interest. This badge was suggested and largely developed by junior member, Erica Nathan, of the Coquina Kids in Florida, to honor the memory of a senior member in

her club who passed along much knowledge and wisdom to Erica.

- **Maps:** the different sorts of maps and how to read them, sources of paper and electronic maps, making maps, and using GPS for such fun activities as geocaching (an activity that was suggested by Dennis Gertenbach, leader of the Junior Geologists of the Flatirons Mineral Club of Colorado).

My goal is to have a revised badge manual with the new units, as well as some additions and revisions to existing units, posted to the AFMS web site before the end of January. So if your society is actively using the AFMS/FRA Badge Program, watch for updates coming soon!

If your society is not using the Badge Program, why not? It's FREE! And it's been built to help you help your club's kids learn the many facets of our fascinating hobby—all the while, having fun!

**AMERICAN LANDS
ACCESS ASSOCIATION
PLAC/ALAA Joint Meeting**

The joint meeting of the Public Lands Advisory Committee and the American Lands Access Association was held following the Directors' meeting on Saturday. The meeting was open to everyone who is interested in and uses our public lands. We had very good attendance. Over 30 people attended including 7 officers and directors of ALAA attended.

Rudy Mendoza, the Field Rep for Congressman Devin Nunes of the 21st District (Visalia) talked about 3 bills currently before the House: (more details about these bills are on the ALAA web site - www.amlands.org)

- H.R.1581 Wilderness Study Area and Roadless Release Act of 2011
- H.R.758 National Monument Designation Accountability and Transparency Act of 2011
- H.R.199 Government Litigation Savings Act of 2011.

These three Bills are of great interest to our rockhounds and users of the public lands, and great importance to how we conduct our activities and our hobby. Mr. Mendoza told us the best way to support these bill is to send letters of support and your opinion to your local Congressman and Co-sponsors of the bill. Your letters make a difference and re important.

Because of the legislative load and Congress being bogged down with fiscal issues these bill have little chance of being passed this session and will be reintroduced at the new session in January.

Amy Granat told us about a laws suit that is being filed against the USFS concerning access and use by the elderly and disabled. This deals with road use, how management plans are developed and how it will affect all of us. This suit will affect how all Land Use Plans and Travel plans are developed and written for all USFS and BLM land.

Members**

How frequently does your Society communicate with its members? Is it only once each month via a newsletter and at general membership meetings? Ever wonder why some members don't feel connected to your society and eventually leave?

Consider this: establish an email database which can be used throughout the month to notify members of upcoming events....everything from the monthly meeting reminders, field trips, matters pertaining to the CFMS and AFMS, committee reports, minutes of meetings and a myriad of other issues. Your members feel much more connected with your society when there is constant contact!

So, how is this done? Very easily!

I'm sure there is a more 'formal' method of emailing individuals using existing retail database software such as Microsoft Access, Microsoft Excel, etc., but I've found it VERY EASY and EXTREMELY EFFICIENT to just do the following:

Step one: establish a Microsoft Access database of each of your Society's members.

Step two: alphabetize your database based upon each member's last name.

Step three: create a Microsoft Word document which lists each email address in the alphabetized listing.

Then, when sending a 'mass email' to your society's members, just 'copy-and-paste' the emails in that Microsoft Word document into the 'To' (or, preferably, into the 'Bcc') portion of the email. Then just type your email and hit "Send". It's that easy!

Last year we saw the change of national leadership of the Sierra Club and the Wilderness Society, two of the country's most powerful environmental lobbying organizations. With this being an election year both Congress and the state's legislative bodies will be busy trying to preserve their jobs for another term. This may have slowing effect on negative impact legislation involving the Rockhound Community. This is the perfect time for Rockhounds to get involved in helping to preserve the hobby of the amateur collecting of Rocks, Minerals and fossils on our public lands. As concerns over access issues become public please take the time to contact the responsible agency or your elected official to voice your opinion on the issue. This will show that the Rockhounds are educated on the issues and are willing to communicate with the responsible body or agency to voice their views and opinions. Now is the time to become a Rockhound Activist and speak up to protect the Rockhounding Hobby on America's Public Lands.

The stewardship and management responsibilities of these public lands have been given to the US Forest Service and the Bureau of Land Management to hold in trust for the American People. These agencies are to manage these public lands in the best interest for all users for the betterment of recreation, commerce and reasonable amounts of conservation.

As planning progresses for this year's fieldtrips keep in mind the AFMS Code of Ethics and the AFMS Land Use Policy as guides for the Rockhound's Stewardship responsibilities while enjoying the great outdoors and the public lands on which most collecting sites are found. It is a good idea to communicate with the agency responsible for the management of the area where the fieldtrip will be to learn of any new rules or regulations that will help avoid any negative impact to the access of the collecting site or material collection. This will educate the agencies that rockhounds are in fact an active part of the public and deserve recreational opportunities on America's Public Lands.

ASK...and YOU SHALL RECEIVE

I hope many of you have seen the CFMS Historical Cab collection.

How many of you know how and why it was started? Back in 1997 the AFMS had their 50th Anniversary in Jackson, Mississippi, (hosted, by the Eastern Federation). Three people were asked to create something special for the celebration. We decided on asking clubs and individuals throughout the U.S. to send us cabs and we would put them together as a exhibit. It was so successful that we had three cases. At the end of the celebration we decided to send the cabs back to each regional federation, asking them to create a traveling exhibit and add to the exhibit.

Since CFMS had been so generous, more than any other regional federation, I ask for approval from the CFMS directors to keep the cabs and create the CFMS Historical Cab collection. It has been added to through the years since 1997 and we have either two or three cases, depending on the availability of space at the CFMS Federation show each year.

Which brings me to what happened at the Anderson, CA, site of the CFMS Show and Director's Meeting. I mentioned that I had two wishes: one to have a botryoidal jade cab from Jade Cove area and one to have a myrickite, from the Napa area.

At the Fall Business meeting of the CFMS directors I was presented, by the Director from the **South Bay Lapidary and Mineral Society**, two stones. **Terry Vasseur**, editor

for the club had heard my plea, went through his vast rough collection and came up with both pieces, the myrickite was in a collection he acquired and had seen the rough piece some time back, and the botryoidal jade rough was personally collected by him and they were the two stones I wanted. I can't thank Terry enough for his personal sacrifice of these two stones. They are beautiful, beautifully done and will be added to the collection so everyone can see them at the CFMS show in 2012.

I thought you might want to know more about myrickite, it was discovered in Yolo County, California. It is composed of cinnabar (mercury) in chalcedony and in opal. The mercury give this rare stone a beautiful red coloring, making it valuable and highly prized. It is similar to the national stone of China, called chicken blood stone because of its red coloring. Myrickite was mined in the Manhattan Mercury Mine, now part of the McLaughlin Gold open pit mine owned by Homestake Mining near Lower Lake, Northern Napa Valley, Yolo County, California (written by Sharleen Harvey, daughter of Helen Rice, of the Rice Museum in Hillsboro, Oregon)

And there you have it. Ask and you shall receive. I better watch what I ask for after this.... Next time it could turn out badly.

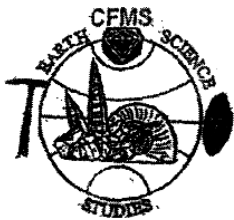
