### SAFETY REPORT

This month I'm going to talk about breathing protection, both in the field and around the house or in the shop. There are some choices for different levels of protection. For larger dust particles or saw dust a fiber mask will do. It does a fairly good job. A problems is when you exhale and are wearing safety glasses they can get fogged up causing another problem of not being able to see. The next step up is still a fiber mask, however this one has a exhalation valve. innovation won't fog up your eye protection unless of course you are wearing a face shield. The next version is a respirator type with one or two filters on the mask. What is nice about this is you can get filters that remove common dust to filtering molds and even make things smell better. All these are interchangeable on the mask. The next type is a respirator with a full mask and is a closed system with having a tank of compressed air or pure oxygen just like the ones firefighters wear.

Of course any of these masks could be compromised by someone with a full beard. Even though there is that problem, it's still better than a wet bandana in a dust storm. The other annoyance is there is no way for someone to be able to drink coffee or whatever when wearing any of these devices. You'll just have to take them off before drinking whatever.

To date this year, the Show Dates Committee has received the following number of show submissions for Website Posting and inclusion in the CFMS Newsletter. Merryan O'Neill has been graciously filling in for the new webmaster posting the forms online, while I have been posting them for the CFMS Newsletter. We have been cross checking each other's work for errors.

- •18 Local Shows are listed to the end of 2019 and into 2020. These dates are received via email from an online form that members fill out and are then forwarded to my RGMS Director's email.
- •Year to Date 56 Show submittals were received. The National and Regional shows are listed until the show is past. These shows are listed with bold font and are a larger font size to draw attention to them. The information is up-to-date for 2020.

- Each month I cross check all show information that appears online against what I have received to make sure we match. Merryan and I contact each other if we find missing submittals, so corrections occur monthly before the newsletter is published.
- I will always respond to the email submission that I received it. If you don't receive that email, I did not get your submission.
- •Realize that this is free advertising and the longer it is posted, the more folks have a chance to see what is happening in the area they are visiting.
- Each month, I pull that printed copy of the show dates and I post those shows on my club's bulletin board so they are visible to everyone who visits.
- •All submittals should be entered before month end to be listed two months from the date. The Show Dates article submitted in October will appear in the December newsletter.

### **INSURANCE**

CFMS Fall Business Meeting-Visalia, CA-11/9/2019 By Fred Ott, Insurance Chair

"Insurance Checklist"

With the many recent wildfires throughout California, it's now more important than ever to make sure that the assets belonging to your society are properly covered with adequate insurance.

### If your society owns a building:

- •The amount of insurance coverage should reflect the 'full replacement cost' of a new building....including demolition costs....not the 'market value' of the property.
- •The policy should include "building code upgrade" coverage (also known as "building ordinance or law" coverage) which would pay for the increased cost of construction as the result of 'current building codes'.
- •The policy should provide adequate 'premises liability coverage' to protect your society against claims and lawsuits.

### If your society rents/leases a facility (whether for meetings, storage, lapidary, etc.):

•Be sure to purchase 'premises liability insurance coverage'

# If your society owns tangible business personal property (such as lapidary equipment, office equipment, supplies, furniture, etc):

- •The amount of insurance coverage should reflect the 'full replacement cost' of all items, not the 'Actual Cash Value/Depreciated Value' of those items.
- •Be sure to conduct a 'photographic inventory' of everything owned by your society and keep the photos 'off-site or in the 'cloud'

#### If your society owns vacant land or a claim:

•Be sure to purchase adequate "liability coverage" for any claims that might arise from the ownership or use of the property. Are the members of your Board of Directors covered for their actions and decisions on behalf of your society which may jeopardize them personally and financially? If your society hasn't already purchased Directors and Officers Liability Coverage, the Federation's insurance program offers a very affordable D&O policy.

Sometimes it is difficult to recognize the value of the Federation's Insurance policy and how it protects CFMS societies and their individual members, so I thought it best to provide a little 'history' as well as some examples of actual CFMS claims that have been paid throughout the years.

Almost 20 years ago.....prior to the current Chubb policy....and before McDaniel Insurance Services, Inc. became the Federations' insurance agent.....the 'per CFMS member premium' for the Federation's General Liability Insurance policy was only \$1.00 per year per member; it is now \$6.00 per year per member. Things went very smoothly for many years; then all hell broke loose!

A claim involving the death of a CFMS member on a field trip cost the CFMS's insurance company \$250,000 and the insurance carrier at the time, now recognizing the exposures posed by 'rock and gem clubs', dropped the Federation's insurance policy 'like a hot potato' leaving Bob Stultz and Pat LaRue to frantically search for a quality replacement agent/carrier. Contrary to some beliefs, getting liability insurance coverage for rock and gem clubs whose activities include rockhounding, mining, lapidary, rock-and-gem shows, etc. was not then (and is not now) an easy task. Fortunately, Bob and Pat located Patt McDaniel and the relationship that they established with McDaniel Insurance Services has been excellent ever since that fateful era.

### Some actual claims paid by our Federation's insurance policy include:

- •Theft of hand tools, tile saw, vacuum pump, air compressor and lapidary equipment,
- •Vandalism and burglary including gems and silver
- •Burglary involving tools and stones
- •Liability claim involving the rental of a truck to transport Society assets

- Damage to a display case and its valuable contents caused accidentally by a club member
- Water damage to a building and its contents
- Major fire damage to a building and its contents

As you can see, the Federation's insurance company doesn't "just collect premiums"; they <u>pay claims</u> for losses incurred by the Federation and its member societies, so it's <u>very</u> important that each society obtain insurance to cover the assets of the society as well as liability claims that occur on a regular basis. PS Patt McDaniel asked that I also mention that several claims have been submitted wherein the amount of loss (theft or damage) to property owned by a society was less than the amount of insurance purchased by that society. All the more reason to make sure that your society has adequate limits of coverage.

### **ROCKHOUND SOAPBOX**

Recreational Rockhounding as defined in the United States Code of Federal Regulations 43 CFR § 8365.1-5 Property and reso urces,

- (a) On all public lands, unless otherwise authorized, no person shall:
- 1) Willfully deface, disturb, remove or destroy any personal property, or structures, or any scientific, cultural, archaeological or historic resource, natural object or area.
- 2) Willfully deface, remove or destroy plants or their parts, soil, rocks or minerals, or cave resources, except as permitted under paragraph (b) or (c) of this paragraph; or

- (3) Use on the public lands explosive, motorized or mechanical devices, except metal detectors, to aid in the collection of specimens permitted under paragraph (b) or (c) of this paragraph.
- (b) Except on developed recreation sites and areas, or where otherwise prohibited and posted, it is permissible to collect from the public lands reasonable amounts of the following for noncommercial purposes: 1)Commonly available renewable resources such as flowers, berries, nuts, seeds, cones and leaves.
- 2) Nonrenewable resources such as rock and mineral specimens, ommon invertebrate and common plant fossils, and semiprecious gemstones;
- 3) Petrified wood as provided under subpart 3622 of this title:

4) Mineral materials as provided under subpart 3604; and

#### Subpart 3604—Free Use of Mineral Materials

- 5) Forest products for use in campfires on the public lands. Other collection of forest products shall be in accordance with the provisions of Group 5500 of this title. PART 5500—NONSALE DISPOSALS; GENERAL
- (c) The collection of renewable or nonrenewable resources from the public lands for sale or barter to commercial dealers may be done only after obtaining a contract or permit from an authorized officer in accordance with part 3600 or 5400 of this chapter.

## ELECTRONIC COMMUNICATIONS

Streamlining Your Society's Communication—Quick and Easy

Has your society considered creating an electronic mode of communication to contaect your members between meetings? Many societies have, and it is working beautifully for them. The benefits are many.

When you create an email contact roster for your membership, you are able to send a message to everyone within about 5 minutes, depending how large your membership is. Some computer systems vary in the number of grouped addresses you can send in one email. For some it may only be no more than 15 at a time. That's not a problem, because you'll still be able to get the job done, lickety-split! I send out the announcements in 6 groups to all of CFMS' membership and the CFMS Chairmen and Officers within minutes.

Many societies now email their bulletins each month to their members which saves on their piggy bank in postage and printing costs. Some societies still prefer to snail mail their bulletin, because they have members who don't have computers or aren't up to speed with the computer they do have. In this case your society can snail mail the bulletin to those members who aren't computer savvy, and email the bulletin to the others. That said, it is always nice to have a few printed bulletins on the table to give to guests who visit your society.

Remember many years ago when societies had a phone committee? I do because I was on one. Imagine how much time your society will save by sending out reminders or last minute details or changes in an email. You can always call that small list of members you don't look at a computer.

You don't have to be a computer geek to organize an email roster. If you are one of those people who types and prints an annual Christmas to send en mass to friends and relatives you are perfect for the job.

### The Bare Necessities if Your Society Doesn't Have a Computer Geek

I use Word, but you may have other programs you like to use.

1. In a vertical column, type your society's member names in alphabetical order, last name first.

Crockett, Davey Mouse, Mickey Poppins, Mary

2. Next to each member's name, type in their email . . address and activate the address by hyperlinking it.

Crockett, Davey:racoonhat.com Mouse, Mickey:bigears.com Poppins, Mary:squirrelsintheattic.com

3. Start a new section in a paragraph form just for the email addresses. Add them one by one starting from the top of your list in 2

racoonhat.com; bigears.com; squirrels in the attic.com

Now you are ready to use your new communication system! Be sure to send the announcements. Blind copy. This will help prevent hackers from invading one computer into another. Your member's names and email address sections are in order, making it easy to find and make changes when you need to.

Talk to your society about the information you've learned in this article. If they like the idea, they'll need to designate someone to create, maintain and be an instrument for the system. If they travel with their computer where there's Wi-Fi, sending announcements to members stays easy.

Nothing will ever replace to warmth of the human voice when you want to thank those chairmen for the great job they are doing, etc. However, having an electronic communication system can save your society time and some money.
