#### PROGRESS WITH DIGITIZING

In early December, I made two visits to the cache of documents in Lancaster. I have now removed all materials that I feel will need to be scanned, and I have stored in Lancaster two boxes of duplicates of newsletters and of newsletters of member societies.

The materials are now organized by decade into fourteen banker's boxes. During the seventies and eighties, two boxes are required each decade. Apparently the Federation generated a lot of paper in those days. A number of "problem documents", whether undated or spanning several years, fill two boxes. I also have a box for items from individual clubs and from AFMS or another Federation. These I will make available at this meeting.

As I wind down the project of digitizing newsletters, I must now shift my attention to other records, such as rosters, minutes, show folders, field trip handbooks, and so forth. I will continue to emphasize those materials that can be easily unbound (e.g., removing staples) simply because the scanning goes much faster.

I continue to appeal to members to check their storage areas for issues of Gems and Minerals Magazine from 1951 through 1963. Heidi Hall of Santa Rosa has contacted me about some issues her club possesses, and has agreed to bring those to this meeting for me to borrow. I hasten to add that I do not need to keep your magazines indefinitely. Once scanned or photographed, the magazines can be returned to your club if you wish.

#### **CFMS MEMBERSHIP COMMITTEE**

For the last few months I have been working with the new Rock and Gem Magazine Managing Editor, Antoinette Rahn regarding discount subscriptions for CFMS member club and society members. In the distant past the magazine offered discounts to these members as well as a program where if a club group had significant subscriptions then the organization got a share of the subscription money.

So far, the magazine subscription team has been working on these issues and there is a probability that they could be enacted. Concurrently with this program they are seeking volunteers from the CFMS member clubs and societies to have a table at their annual shows to help sell discount subscriptions to the attendees at their shows.

At our show which happed to be running concurrently with the CFMS Annual Show and Convention, the Mother Lode Mineral Society will be the first society to have a trial run of the discount subscription program for show attendees. It will some version of a discount coupon that will be handed out to the attendees. I haven't seen a copy of the coupon yet. They will be sending me a considerable number of copies of the latest issue (April) of the magazine to hand out to our show attendees. Obviously, your club members will be eligible to use the coupons (they are show attendees, right?).

A new program called the "Weekly Review" for subscribers either mailed copy or email copies is a weekly message discussing some of the previous articles, new information articles or a newly created category called "Club Corner". This category will be featuring clubs throughout the realm of the magazine. The Club Corner report will be featuring a demonstration, group outing or dig, community support project or any special activities that the club has been participating in or special activities held during an annual show. This is an outstanding opportunity to promote your organization! The first issue of this Weekly Review featured the Mother Lode Mineral Society and one of our demonstrators - Jack Hoque.

We were fortunate to have Jack Hoque the glyptic artist featured in an article that I wrote for the December issue to come down from Medford, Oregon to do a demonstration at our monthly meeting of his fantastic artistic carving intaglio images on the back of quartz crystals. This was a trial run to test our lighting and camera setup because he will be a featured guest exhibitor at our show on March 9-10 in Turlock, CA.

Because we continue to have a dedicated membership table at our show, we will be using it to also present the discount subscription program to anyone and everyone at our show. We expect this table to be much busier than usual and that is great for us because it will give us more visibility and more opportunities interact with the show attendees and to recruit new members.

I continue to highly recommend that all clubs and societies have a fully manned and dedicated table with a prominent membership sign out in the dealer mix of tables on the showroom floor. This is your best opportunity to recruit new members that you will have all year. Don't squander the opportunity. This table should be given maximum importance for your show. It definitely works! We signed up 41 new families/individuals at our show last year!

#### PUBLIC LANDS ADVISORY COMMITTEE

To start with, all of the legislation that was being proposed to limit access to public


lands in the area covered by CFMS died in committee on January 1, 2019. By February 15, 2019 more than 54 new bills have been introduced in congress under the heading of Parks, Recreation Areas and Trails and may have affects on Recreational Rockhounding on Public Lands across the nation. If any of these new bills before congress appearP to have a negative effect for Recreational Rockhounding the CFMS PLAC Committee will strive to inform the Executive Committee of the situation and will attempt to provide a reasonable course of action which CFMS may decide to follow.

The issue of Recreational Rockhounding areas and their access routes continues to be a major issue for Rockhounds to grasp. The Recreational Rockhounding areas within the area covered by the CFMS is not secure and may be in jeopardy of closure at any time when Public Land Management and Travel Plans becomes a public issue.

A prime example of this is the Mojave Trails National When the monument was formed all Monument. Rockhounding activities within the boundaries of the monument was suspend and was not allowed by congressional definition of a National Monument. (No Natural Resource may be removed from a National Monument) Because Rockhounding had been allowed as a Recognized Recreational Activity prior to the creation of the monument, Senator Feinstein sent at letter, to then, Secretary of the Interior Sally Jewell asking her to allow Recreational Rockhounding to continue as allowed by law until the final Monument Management Plan is complete. This is the reason collecting is allowed in the monument. The BLM was given 3 years to complete the Monument Management Plan. If Recreational Rockhounding is not in the final Management plan as a Recognized Recreational Activity, Collecting of Rocks, Minerals, Fossils, etc., will not be allowed.

After attending several BLM Meetings on this issue and talking with the Field Office Managers responsible for the Monument Management Plan their comments were that Recreational Rockhounding will not be allowed as a Recreational Activity in the Monument as a whole and their advice was to submit to the BLM, during the Public Comment Period, a list of collecting sites and access routes required to get to and from the sites.

So, in order to provide a united front of Recreational Rockhounding to the BLM when called upon, a "Fieldtrip Journal for Public Lands" has been created and is in Beta Test with several Clubs/Societies. After the Beta Test is complete and the form finalized, the form will be made available for all Clubs and Societies to use. We will be asking for the Field Trip Leader to see that the forms are completed as much as possible and be kept available so when a threat of access and site closure becomes of public interest, the area and the data can be compiled, put into the proper format and submitted to the Public Land Management for consideration. We are not looking for any "Secret Collecting Sites" but if that site becomes in Jeopardy of Closure by Regulation or Management Decision, the information can be used to help keep the site and site access open for Recreational Rockhounding. As part of any Public Land Management Plan, All Access Routes must be identified and assigned a Route If the route to a collecting site is not identified with a Designated Route Number that Route, Road or Trail is closed to all mechanical travel and the collecting site is lost. Therefore it is imperative to the Recreational Rockhound that this data be collected in order to preserve the Recreational Activity of Rockhounding. This is true in the recently created National Monuments and all collecting sites on all Public Lands within the area of CFMS. This needs to be accomplished using current 21st Century
