One Last Call for Kids Exhibits at Our CFMS Show

I'm happy to note we've received entries for our **2022 CFMS Junior Achievement Award**. Thus, I look forward to the honor of rewarding a deserving child during the Awards Banquet at our upcoming CFMS Show & Convention May 6-8 in Lancaster!

Speaking of the CFMS Show, I continue to ask my fellow CFMS-affiliated clubs and societies to do all you can to encourage kids to enter exhibits. For exhibitor applications and other show info, see the CFMS website at <u>https://cfmsinc.org/2020-cfms-show-forms/</u> As noted in previous newsletters, a special one-time award for **Outstanding Junior Exhibit** will be determined and presented by 2022 CFMS Show Chair Susan Chaisson-Walblom. The award will consist of a Certificate-of-Achievement, a \$100 cash prize (donated by Jim Brace-Thompson) and a mineral specimen (donated by Susan Chaisson-Walblom).

There is just one rule for this award: the exhibit should reflect the interests and efforts of the child, not a parent, and the kids' exhibits should be set up by the children themselves on set-up day prior to the show. The award may be presented to any exhibit—whether competitive or noncompetitive—entered by a pebble pup or junior under age 18. In short, it is like the CFMS President's Award granted to whatever display appeals most to the CFMS President.

We offer this special Outstanding Junior Exhibit award in an effort to encourage kids to exhibit after the hiatus in CFMS Shows due to the pandemic. Here's hoping *your* club encourages kids to enter. See you at the Show!

Directions:

From El Centro, CA, take Interstate 8 East to Highway 111 North. Drive North on Hwy 111 to Highway 78. Turn east on Hwy 78. Continue driving on Hwy 78 towards Blythe/Palo Verde for approximately 72 miles. Turn left on the Bradshaw Trail/30th Avenue and continue West for approximately 11 miles to Milpitas Wash Road. Turn left on Milpitash Wash Road and follow signs to the Hauser Geode Beds. **From Yuma, AZ**, take Interstate 8 West to the Ogilby Road exit. From I-8, head North on Ogilby Road toHwy 78. Turn right on Hwy 78 and drive approximately 34 miles. Turn left on the Bradshaw Trail/30th Avenue and continue West for approximately 11 miles to Milpitas Wash Road. Turn left on Milpitas Wash Road and follow signs to the Hauser Geode Beds.

Please dress in layers, bring your own hat, sunscreen and wear hiking shoes/boots as we will be walking over uneven terrain. Also please bring your own water and snacks.

AFMS SCHOLARSHIP FOUNDATION

The question often comes up of "What does AFMS Scholarship Foundation do?" Well, one thing that the AFMS Scholarship Foundation does is sponsor scholarships for graduate students.

The Foundation was established in 1964 with the purpose of financially aiding young men and women in acquiring an education in the field of Earth Sciences. The AFMS Scholarship Foundation runs only on donations. The first scholarship was given in 1965. The first scholarship was for one student for \$300.00 per year for two years. It is now given to two students per participating federation in the amount of \$4000.00 each.

The Scholarship Foundation allows the regional federations to honor a member of their community by allowing the honoree to select a worthy candidate.

Since 1972, each participating Regional Federation has selected their own Honorary Award Winner who then selected the school(s) and assisted with the selection of the student, or students, who then received the scholarship grant(s). This indirect method has served our purpose perfectly in that it benefits students.

The funding comes only from donations!! It has been very difficult for the Foundation, like everyone else, due to the Covid pandemic. Now that we are starting to regain some normalcy, the Foundation needs the donations. A generous donation would be a \$1 per member from each society. If a society could donate more that would be wonderful!

The first item you need is a cover form labeled EDITOR'S CHECKLIST. Read the form. The biggest problem is at the bottom of this form. The first line is "Bulletin Name, Month." No problem, if you fill it in. But it causes a problem if you are not entering your bulletin in the contest. So, I have changed the form to show a line for "Number of entries" for Bulletins entered. Please count the number of entries and make sure the number of entries equal what is listed on the Editor's Checklist.

Editors need to look at the Bulletins you prepared for January through March. Practice scoring the articles, poems, features, and your bulletin. How would you score them?

SOME EDITORIAL COMMENTS

Like everything else, interest in submitting your bulletin for evaluation is quite low. I prefer to use the term evaluate instead of judge because that's what I feel that's what the judge is actually doing. The goal is to help the editor create a bulletin that will meet the needs of their readers. I encourage all editors to use the various score sheets to critique their own newsletter.

I was fortunate to have some really outstanding club editors as mentors. I entered newsletters in the annual contests at both CFMS and AFMS levels and learned from each experience. These experiences were during a time that there would be 15 to 20 entries in the small bulletin category. I did earn two CFMS and one AFMS awards with my prospecting club bulletin.

As a judge for the past few years I've found that the bulletins are getting better and better. I believe contest participation has made that happen. Please consider an entry for 2022.

WORD SAFETY

What does one do when they hear someone shout, "No, Stop!" Doesn't everyone stop, look around and assess the situation? So, what might one do when they hear someone shout, "Crumbles!" if a quarry rock face suddenly crumbles? Words can have safety meanings. Crumbles just does not have it.

What about words such as "Person overboard!", "Fire!", "Flood!", "Help!", "Run!", "Watch Out!"... Shout "Hamburger!" and see what happens besides people showing up with plates and appetites. Some might shout back "Where?" or "It's about time!" Perhaps there is a class on word safety. I don't know of one. Though words used during duress or emergency has potential for a class.

The ideal situation would be that there never be a need for words needed in an emergency--would that people not wander near working faces or well beyond the drop zone of falling material; people stayed off dangerous/loose rock slopes; people did not collect under overhangs; people heeded warning labels of chemicals for rock cleaning solutions; people minded safety protocols for torch handling. Safety is many things--a situation, a knowledge, a balance of activity gone wrong, a rule, a reaction. Knowing the right word usually comes naturally.

Professionals use words, well trained words. Professionals practice strategy, practice dangerous situations, prepare for emergencies and the right words to say. The average person does not. The average person rarely has the opportunity to rehearse in real life situations, and rarely has the means to practice responding to the unexpected.

A well-placed scream is effective in the movies. It certainly alerts the people in the area that something is amiss. In real life, it does much the same and still remains rather unspecific. It could be uttered in non-emergency situations as well. At least it draws attention. And that, in and of itself, might work.

There are many other words of safety. They reside in lecture language, warning label laments, tag talk, instruction manuals, pit protocols, quarry questions, fine print points, prescriptions pronouncements, flag fancies, tape barrier signs. etc. Would be that those words preceded and prevented the need for shouted expletives and warnings. It is up to us to use the words wisely, know the use and misuse of words and how they can help us be safe.

Would that words not be uttered as in emergency because the emergency never occurred. But if an emergency should occur, that you have on hand the right words to bring about as safe a solution as possible

One of the things that can be practiced is word safety. All the best words to you and yours.

Be safe, please. Your safety matters.
